 - Classify as USD student taking the majority of classes at a physical USD campus or remote site (i.e., USD Community College for Sioux Falls). This includes students whose on-campus classes transitioned to remote instruction due to COVID-19. Students in an online only program were ineligible for a grant.
 - Be in good academic standing and maintaining satisfactory academic progress with the university.
 - Students have to be Title IV eligible.
 - Demonstrate the expenses related to disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care and child-care expenses.
 - The amount of each grant awarded was determined by a student's Expected Family Contribution (EFC) from the 2019-2020 FAFSA. Students that had an EFC of less than \$8,500 received a grant of \$500; students with an EFC greater than \$8,500 received a grant of \$250.
